

VIRTUAL TERMS

General

The terms and conditions below apply to all aspects of chimposium.com (the “Site”) and Chimposium 2021 (the “Event” - part of the Chimposium training series). Before completing your registration or purchasing your tickets with the Site or Events we ask that you read the terms and conditions set out below.

The Site and Event are owned by the Chimposium brand, a subsidiary of Perfect Blend t/a Chimp Answers.

These terms may be amended without notice to you. Your continued use of the Site, the Events and other Chimposium products will mean that you accept these changes.

Perfect Blend t/a Chimp Answers reserves the right to cancel, change the date of, or relocate the Chimposium Event at any time prior to the Event Date.

You agree to obtain, at your own expense, appropriate and sufficient insurance against any risk of loss associated with the Event being cancelled, postponed, rescheduled or relocated.

Force Majeure

In this clause, Force Majeure means circumstances which are beyond the reasonable control of Perfect Blend t/a Chimp Answers and which are reasonably likely to affect Chimp Answers successful delivery of the Event or would make it inadvisable, impracticable, illegal, or impossible for a party to perform its obligations as originally contracted under these Terms & Conditions, including: fire, flood, earthquake, extreme adverse weather conditions, failure of electric power, gas, water, or other utility service, collapse of building structures, widespread disease or other public health emergency (including pandemic or epidemic), strike or other industrial action, the outbreak or declaration of war, act of terrorism, revolution or government orders or action (including the declaration of a State of Emergency or Coup d'état).

If, as a result of Force Majeure, Perfect Blend t/a Chimp Answers cancels the Event, Perfect Blend t/a Chimp Answers shall use reasonable commercial endeavours to reschedule the Event. Without prejudice to its obligations, Perfect Blend t/a Chimp Answers accepts no liability and will not be liable for any compensation where the performance of its obligations under these Terms & Conditions is affected by Force Majeure.

Ownership and Copyright

Admission Policy

Any self promotion or distribution of materials from any non-sponsors is forbidden on our virtual platforms.

Without prejudice, the organisers reserve the right to exclude any person(s) from accessing the Event.

Cancellations & Refund Policy

Requests for cancellations and refunds must be submitted in writing to support@chimposium.com with the details of your ticket. We will refund your payment to the original payment method less a 10% admin fee as follows:

- On or before 30th September - 100% refund
- On or before 4th October - 50% refund
- On or before 6th October - 0% refund

Attendees will have a 48-hour period after purchasing an add-on (e.g. Recordings) to apply for a refund after that time no refund will be given. Once the recordings are available, the 48-hour period becomes invalid and all add-on purchases will gain immediate access. For that reason, refund requests will no longer be eligible.

If your ticket is cancelled due to malpractice or misuse of discounts no refund will be issued (Please see discount conditions for more information on this). Perfect Blend t/a Chimp Answers reserves the right to refuse any refund based on management discretion.

Discounts & Codes

Discount codes cannot be combined with any other offers or credit received from any Chimposium event or product. Any credit issued must be used by the original recipient and cannot be transferred.

Discounts cannot be retroactively applied to a completed ticket purchase. Additionally, refunds or credits cannot be issued of equivalent value to any offered discounts or promotions.
